Bids were opened in the Business Service Conference Room of Cecil County Public Schools on November 5, 2018, at 2:00 p.m., for Bid# 19-05: Copy Paper. A Notice to Bidders was posted on the eMaryland Marketplace bidding board October 23, 2018, with email notifications sent to 146 prospective bidders. On October 24, 2018, five (5) bidders were sent a Notice to Bidders by CCPS email. The Intent of this bid is to establish a contract with a qualified supplier at firm prices for the handling and delivery to schools of copy paper. The initial one-year contract period will begin on January 1, 2019, and end on December 31, 2019. One (1) additional one-year contract renewal period is possible pending funding, satisfactory performance, and pricing.

Three (3) bidders submitted pricing for various types of copy paper. The Purchasing Department recommends that the Board of Education of Cecil County approve a contract to the bidder meeting the required specifications. The lowest responsive and responsible bidder is W.B. Mason for a total amount of \$459,838 for the entire cooperative bid award. The Cecil County Public Schools portion only, is an estimated annual contract amount of \$230,266.
