Bids were opened in the Business Services Conference Room of Cecil County Public Schools on November 29, 2018, at 2:00 p.m., for Bid# 19-07: Food Storage and Delivery. A Notice to Bidders was posted on the eMaryland Marketplace bidding board on November 14, 2018, with email notifications sent to 69 prospective bidders. Thirteen (13) bidders were sent a Notice to Bidders by CCPS email.

The intent of this bid is to establish a contract with a qualified Contractor at firm prices for the pick-up, receiving, commercial storage, inventorying, handling, and delivery to schools of processed food products purchased by the Cecil County Public Schools Food & Nutrition Services Department. The initial one-year contract period will begin on January 1, 2019 and end on December 31, 2019.
