## **Public Content**

Bids were opened in the Cecil County Board Meeting Room at the George Washington Carver Education Leadership Center on March 29, 2019, at 2:00 p.m., for Bid# 19-18: Drivers' Education Classroom Instruction. A Notice to Bidders was posted on the eMaryland Marketplace bidding board on March 8, 2019. Five (5) MDOT MVA certified and licensed driver's education schools were contacted and sent notifications by email. The Cecil County Chamber of Commerce was also notified and the Notice to Bidders was posted onto the CCPS.org website.

On behalf of the Education Services – Secondary Schools, the Purchasing Department is recommending an award of contracts to three (3) bidders for the purpose of establishing contracts with local Maryland Department of Transportation (MDOT) Motor Vehicles Administration (MVA) certified and licensed driving schools located in Cecil County. Bidders were asked to offer discounted rates except where regulations prohibit discounting.

The 'Behind-the-Wheel' training is included for bidding purposes as the students will sign a contract with the awarded driving schools, but there will not be any behind the wheel student driving during the school day as part of this bid.

The initial one-year contract period will begin on or about August 15, 2019 and end on or about June 30, 2020. Up to four (4) additional one-year contract renewal periods are possible pending funding, satisfactory performance, pricing, and the need for the specific services as determined by CCPS. The contract maturity date is June 30, 2024.
