INTERGOVERNMENTAL BID - LEASE TWO COPIERS

Delmarva Document Solutions, a certified Xerox dealer, was chosen utilizing the NASPO ValuePoint RFP NP-18-001/Contract BPO001B0600215, for the lease of two (2) Xerox D125-CP commercial monochrome copiers, configured identically, for Print and Distribution Services. This is a replacement of the existing Xerox D125-CP copiers leased five years ago. The Lease Agreement includes all consumable supplies and full service maintenance for an annual price of \$23,431 each excluding paper, or a total of \$46,863 for both, and a total of \$234,314 over the (5) five-year Lease Agreement utilizing locally budgeted funds.

INTERGOVERNMENTAL BID - TWO WALK-IN FREEZERS

These Food and Nutrition items are being installed to add capacity to the existing freezer storage at Charlestown Elementary, \$64,445, and North East Elementary, \$81,758, for a total of \$146,203. All price quotes include delivery, site prep, and installation plus warranty. The Keystone Purchasing Network

(KPN) Contract #202007-04 for Food Service Equipment, Supplies, and Services is used for the contract piggyback for these purchases. The contract expires February 28, 2022 with renewals possible until 2026. Items purchased are funded by the Food and Nutrition operating account for FY22.

RFP #22-06- Wi-Fi EQUIPMENT UPGRADES

Requests for Proposals were opened at the G.W. Carver Center on January 4, 2022, for the RFP # 22-06 Wi-Fi Upgrades Project for FY22. The Notice for Proposers was posted on November 15, 2021, on the FCC's (E-Rate) Form #470 Universal Services Administrative Services (USAC) portal to begin the E-Rate Competitive Bidding Process. The RFP was also posted on the e-Maryland Marketplace Advantage bidding board, CCPS website, and the Cecil County Chamber of Commerce on the same date. The scope of this project consists of upgrading existing wireless network access points and the associated management platform. The desire is to replace 1,201 access points in 30 physical buildings with 1,378 next-generation Wi-Fi access points. An in-place performance evaluation was conducted between the top two submittals. On behalf of the Technology Services Department, the Purchasing department recommends that the Board of Education of Cecil County award the lowest responsive/responsible bid to Data Networks, Inc. in the amount of \$1,198,860. This project will be implemented in FY23 using local funding with anticipated reimbursement from the eRate program.
