Bids were opened in the Cecil County Public Schools Board Room at the George Washington Carver Education Leadership Center on November 3, 2022, at 2:00 p.m., for CCPS RFP #23-07: Secure Entrances at Multiple Sites Project.

A Notice to Contractors was posted on the eMaryland Marketplace Advantage bidding board on October 11, 2022, with email notifications sent to prospective contractors. Prospective Contractors were also notified through Garden Reprographics, a construction document service provider, as well as the Cecil County Chamber of Commerce. The Notice to Contractors was posted on the CCPS.org website on October 11, 2022.

The scope of this project is to provide four elementary schools with safe and secure entrances. All four schools have different designs and different needs but all have very similar scopes of work. All schools will receive secure vestibules that will prohibit any visitor from entering the school without the administration's approval. In addition to the secured entries, the main offices will be renovated to clearly define public boundaries and provide a sense of security for the students, faculty and staff. Renovations include but are not limited to demolition, new casework, electrical, data outlets, new flooring, ceiling tiles, plumbing, and HVAC. The individual scopes are listed in the Project Manual for each school.

<u>Option 1</u> - All labor, materials, bonds, fees, permits, sales taxes, and equipment required to complete the work as specified in project specifications and drawings for the Bainbridge Elementary School, Bay View Elementary School, Charlestown Elementary School, and North East Elementary School.

<u>Option 2</u> – All labor, materials, bonds, fees, permits, sales taxes, and equipment required to complete the work as specified in project specifications and drawings for the Bainbridge Elementary School and Bay View Elementary School

<u>Option 3</u> - All labor, materials, bonds, fees, permits, sales taxes, and equipment required to complete the work as specified in project specifications and drawings for Charlestown Elementary School and North East Elementary School.
