ADDENDUM #1 BID# 24-12: Refuse & Recycle Removal

To: Prospective Bidders:

This Addendum is to provide clarification to the trash/recycle pick-up schedule and to answer questions asked on or before the due date of January 16, 2024. Bidders and related parties will be responsible to have read and understand all documents, the scope of work, addenda, and all related solicitation documents issued. These documents will become attached to and a part of the solicitation and award of the bid contract.

Clarification: Please omit pages 33 and 34 as it relates to the pick-up schedule. The corrected version in on page 22 of the RFP. On page 35, the correct address for Chesapeake City Elementary should read "2801 Augustine Herman Hwy, Chesapeake City, MD 21915".

1. Question: Will the Owner or Contractor pay for trash disposal if the load only contains Owner's trash?

Answer: The Contractor will pay any landfill fees. See page 23: "Landfill: Any costs leveled by the Cecil County Government against the Contractor for co-mingled trash or loads that do not contain only the Owner's trash, are the sole responsibility of the Contractor and neither those costs nor any additional costs may be passed on to the Owner. Any dispute between the Contractor and the Cecil County Government regarding this issue must be resolved by the Contractor without any assistance from the Owner."

Question: Will the Owner or Contractor pay for recycling disposal if the load only contains Owner's recycling?

Answer: The Contractor will pay any landfill fees. See page 23: "Landfill: Any costs leveled by the Cecil County Government against the Contractor for co-mingled trash or loads that do not contain only the Owner's trash, are the sole responsibility of the Contractor and neither those costs nor any additional costs may be passed on to the Owner. Any dispute between the Contractor and the Cecil County Government regarding this issue must be resolved by the Contractor without any assistance from the Owner."

3 Question: What is the current in-season trash price per cubic yard for the current term of the contract?

Answer: \$4.99 per cubic yard.

4. Question: What is the current in-season recycling price per cubic yard for the current term of the contract?

Answer: \$2.37 per cubic yard.

5. Question: What is the current out-of-season trash price per cubic yard for the current term of the contract?

Answer: \$4.99 per cubic yard.

6. Question: What is the current out-of-season recycling price per cubic yard for the current term of the contract?

Answer: \$2.37 per cubic yard.

7. Question: What is the different between the two different "Schedule Pickups"

Answer: Question was clarified at top of addendum 1 (please omit pages 33-34, these are incorrect. Please refer to page 22 for the pick-up scheduling).

8. Question: Is the Contractor able to use all three Cecil County Solid Waste locations for **trash disposal** of Owner's material (Central Landfill, Stemmer's Run Transfer Station, Woodlawn Transfer Station)?

Answer: This is between the contractor and the landfills.

9. Is the Contractor able to use all three Cecil County Solid Waste locations for **recycling disposal** of Owner's material (Central Landfill, Stemmer's Run Transfer Station, Woodlawn Transfer Station)?

Answer: This is between the contractor and the landfills.

10. Question: If the Cecil County fee for commercial recycling goes to \$0/ton, could Owner's recycling be mixed with commercial recycling?

Answer: Please refer to answer addressed in question 2.
