

CCPS BID #17-05: ASPHALT PAVING AT G. W. CARVER CENTER

The purpose of this memorandum is to provide an award recommendation and additional information for this project, CCPS Bid #17-05: Asphalt Paving at G. W. Carver Center – Parking Lot, which consists of the milling, patching, paving, and striping of all parking lots and driveways of the George Washington Carver Leadership Education Center located at 201 Booth Street, Elkton, MD, 21921.

On October 26, 2016, competitive sealed bids were opened for the purchase and delivery of all labor, materials, equipment, transportation and services necessary to complete the project. Bid submittals were received from four (4) bidders providing pricing based upon the specifications and a pre-bid site examination meeting with November 2016 and April 2017 as start dates for the project.

The lowest responsive/responsible bidder conforming to CCPS specifications was submitted by The American Asphalt Paving Company, LLC, in the amount of \$132,000, for a November 2016 start date to be completed on or about December 15, 2016, and is recommended for the award of bid. Any additional work discovered during the project has predetermined rates for the type of repairs required. It is possible for this contract to increase by a nominal amount not to exceed 10% of the base bid if CCPS determines that additional repairs are warranted.

Funding for these supplies will be purchased through prior year fund balance.

It is recommended that The American Asphalt Paving Company, LLC, of Baltimore, MD, be accepted as award bidder for CCPS Bid #17-05: Asphalt Paving at G. W. Carver Center for an estimated total amount of \$132,000.
