

SUBJECT: CCPS BID #17-02: CUSTODIAL CLEANING DILUTION SYSTEM

**CHEMICALS** 

The purpose of this memorandum is to provide additional information for the award recommendation of CCPS Bid #17-02 for Custodial Cleaning Dilution System Chemicals.

On July 12, 2016, competitive sealed bids were opened for the purchase and delivery of custodial cleaning dilution chemicals used for the cleaning of school and office buildings. Bid submittals were received from six (6) bidders providing unit pricing based upon estimated annual quantities for the school system. After review of bids, one chemical dilution system was chosen to be tested by CCPS staff in at least two locations. It was determined that for various reasons, these chemicals and products were not considered to be an approved equal determined bv our Operations supervisory staff. Therefore. responsive/responsible bidder conforming to CCPS specifications is Interline Brands Inc. / SupplyWorks, recommended for the award of bid for the purchase of cleaning chemicals in a concentrated formula used in existing chemical dilution systems in each CCPS building.

The initial one-year contract period will begin immediately if approved by the Cecil County Board of Education. At the conclusion of the initial term this contract may be renewed, if it serves the best interests of CCPS, for up to four (4) additional one-year periods at the same firm, fixed unit prices as the initial contract period pending satisfactory pricing, product quality and service.

Funding for these supplies will be purchased through annual budgetary funds.

It is recommended that, Interline Brands Inc. / SupplyWorks of Jacksonville, FL, be accepted as award bidder for the Custodial Cleaning Dilution System Chemicals for an annual total of \$39,671.
